In accordance with the policies of this Synod, I have requested a sabbatical from July 1 through September 30, 2010. The Synod Council has approved this request. I am now looking at how best to spend this time accomplishing the purpose of a sabbatical.

In the academic world this time is to be used to retool or expand study or writing in one's field of study. In the church we have been less focused on study. Our understanding of sabbatical comes from this Genesis understanding that even God needs time to rest from what is done every day.

Life is more than our vocation of work. It is true that many of us define ourselves by the job that provides our income. As Christians we understand that we have been defined by our baptism into the death and resurrection of Jesus. I am a baptized child of God who has been called to serve as a pastor and for this time, as bishop of this synod. This is rewarding work.

The fact is that time away from the daily routine gives permission to renew and re-evaluate how this work can be done. That is my intent for this coming sabbatical. Currently DeDe and I are looking at possible travel to South Africa to visit the Rev. Michael and Pamela Nel. There is also the possibility of connecting with some of our

companion synod colleagues. There will also be time to enjoy the grandchildren.

Earthquake in Haiti

On January 19 Lutheran World Relief (LWR) announced that it was shipping health kits and layettes to be distributed to Haitian earthquake survivors.

LWR partner Church World Service will distribute the shipment of 650 health kits and 1500 layettes, the first of multiple planned shipments to Haiti. LWR has committed material resources valued at nearly \$500,000 and plans to send more health kits and layettes, along with quilts and school kits, in the near future.

Your help is needed today to bring immediate relief and continued hope for our brothers and sisters in Haiti. About 3 million people, one-third of Haiti's population, were affected by this earthquake.

On January 19 the ELCA reported that individuals and congregations of the ELCA had contributed more than \$1.2 million to fund relief efforts of ELCA partner organizations working on the ground in Haiti.

Proposed Law In Uganda

The ELCA is "gravely concerned" about a proposed anti-homosexuality bill under discussion in Uganda, wrote the Rev. Mark S. Hanson in a January 8 letter to U.S.

Secretary of State Hillary Rodham Clinton. Hanson, ELCA presiding bishop, thanked Clinton for her recent statements and follow-up actions by the U.S. Department of State regarding the proposed law.

In his letter, Hanson said the law was introduced in 2009 by David Bahati, member of the Ugandan parliament. The law "would, in certain cases, impose the death penalty for persons convicted of 'aggravated homosexuality," Hanson wrote. The proposed law has drawn considerable criticism and concern from human rights groups, religious organizations, various governments and others.


