

A Word From The Bishop



The Rev Wm Chris Boerger

Now I appeal to you, brothers and sisters, by the name of our Lord Jesus Christ, that all of you be in agreement and that there be no divisions among you, but that you be united in the same mind and the same purpose. For it has been reported to me by Chloe's people that there are quarrels among you, my brothers and sisters.

1 Corinthians 1:10-11

This article always begins with a scripture verse and this month I am at a loss. I want to write about making sure that your constitution is up-to-date. That is not a subject that scripture addresses. The fact is that most of us go to the constitution when there are quarrels among us. That is not the

time to write the rules. The rules were written to help us resolve our conflicts or to separate from each other when appropriate with important safe guards.

Twice in my tenure as bishop I have had to raise the possibility of discipline of a congregation because the congregation's and the ELCA constitutions were at odds. In section 9.22. of the ELCA constitution it says: "All congregations of this church shall abide by the provisions of 9.21., 9.62 and 7.46." of the ELCA constitution. These three chapters deal with the criteria for membership in the church, the mechanisms for disaffiliation from this church and for removing a pastor from the call. In the process of merging our predecessor churches, congregations were not required to change their congregational constitutions.

When a congregation is in conflict with the synod or churchwide, or when a congregation is in conflict with its pastor, it is critical that the rules governing the ending of the relationship be clear and consistent. We will work to try to resolve the problem without resorting

to the constitutional processes. When this is necessary, it is important that they agree.

A Word From The Bishop

As a corporation of the State of
Washington the congregation can use the
process in its constitution. If that process is
different from the one described in the ELCA constitution,
I am required to act on this breaking of our mutual
agreement to use the same processes. It would be best
if we all used the same language in the first place. So, I
am asking that you check your constitutions. It is very
important that the language of the model congregational
constitution be used, especially in chapters 7 and 9.

St. Paul calls on us to find our unity in Christ. When we cannot or will not do that, then the constitution becomes our fallback position. The Synod Office is ready to help you with any question you might have about the governing documents of your congregation.

Assembly Focus

Malaria

Malaria is preventable and treatable, yet far too many still die from this disease. A child dies from malaria every 45 seconds. Today, we are in a special moment when we can turn this around. Already, the rate of death from malaria among children has been reduced by a third. And now you are invited to join with the ELCA in working to eliminate deaths from malaria -- for good. HIV/AIDS

Named the "single greatest reversal in human development" in modern times, the HIV and AIDS crisis has claimed more than 25 million lives.
