### Las Posadas At Bethany

Eyes young and old will be shining as brightly as the candles they hold when Bethany Lutheran on Bainbridge Island celebrates *Las Posadas* at 6 p.m. on Saturday, Dec. 12.

The free event is a traditional Mexican reenactment of Mary and Joseph's trials as they travel from Nazareth to Bethlehem in search of lodging and are eventually welcomed into comfort and security.

Youth lead the procession to different parts of the Bethany property where the crowd sings in Spanish "I beg you for lodging." They are told "Pues no puedo abrir" – 'I cannot open up for you.' When the procession reaches the church building they are recognized and welcomed to the warmth

of the sanctuary with the joyful "Entren inmigrantes." Traditional carols are then sung in Spanish. The event is festive and ends with a traditional tamale dinner and potluck, and a piñata for the youth. The service is led by Pastor Eduardo Cabrera who started the New Jerusalem Lutheran congregation in Guatemala, and currently ministers to migrant workers at El Camino de Emaus in Burlington.

In historic Mexican tradition, "Las Posadas," represents the buildup to the Christmas event. For nine nights, beginning December 16 and finishing on the 24th, two children lead a winding procession of townspeople

At the recent question and answer session on issues related to the Churchwide Assembly actions, I was asked if pastors who are conscience bound to not support the decisions made by that assembly would be marked negatively by the bishop or synod office in the call process. I responded that it would not

and that the track record of this synod should demonstrate that. I was requested to put that response in writing. With that background I want to address the call process and how it continues to work in this synod.

The constitutions of the congregation give the authority to call a pastor, associate in ministry, diaconal minister or deaconess to the congregation. It requires a two thirds vote of a legally called meeting to issue a letter of call. There are several preliminary steps, but in the end it is only the congregation that can vote a letter of call.

The Synod Assembly in 2003 adopted a call policy statement. This document establishes the basic structure of the call process. Part of that process is that the congregation completes its ministry profile. That document describes the ministry of the congregation and the skills desired in the person to be called. The synod office uses that document to identify potential candidates to be interviewed by the call committee.

When the synod office brings names to be interviewed, it is our belief that these candidates match the

ministry profile or we will withdraw the name from the list of those to be interviewed. There have been instances where after interviewing the call committee has changed the profile to be clearer in identifying the skills or attributes that they want in the person to be called. #### A Word From The Bishop

There have been instances where the theological position of the potential candidate was expressed. In those instances we work to meet those expectations. This is a dynamic process. We are not always successful in identifying candidates the first time we try. Not every person interested in a particular call meets the profile request.

So, my response is that there is no penalty for a rostered leader speaking their conscience on this or other issues. We are a divided church on these and other issues. The synod office will seek to work with each congregation and each rostered leader so that we might build up the ministry of each congregation and the whole church.

## Jesus, Justice, Jazz Concert

Northwest Washington Synod churches were among the more than 300 participants that packed the Historic Everett Theatre for the *Jesus, Justice, Jazz Concert.* Christian artists David Scherer (Agape) and Rachel Kurtz were the featured performers at the concert, sponsored by Trinity Lutheran College and several area churches. More than \$3,700 was given through a freewill offering to benefit the

ELCA World Hunger Program.

Music included Christian rock, blues and rap. The theme Jesus, Justice, Jazz refers to the ELCA's Youth Gathering, held in July 2009 in New Orleans under the same name. Scherer and Kurtz were featured artists at the event, which focused on faith, service and justice and included community-wide service projects involving 36,000 participants.

Prior to the concert, about 75 youth and adults participated in service-related workshops, including *Mission Trips That Matter, Taking Root* (introduction to a comprehensive hunger education curriculum), and a global hunger awareness activity for youth.

## LPPO Update

lppointern@lcsnw.org 206-464-4133; www.lppowa.org. Well the 2009 elections for our state are over. We have have been breathing a sigh of relief of not having to see any more TV campaign ads or receive any more campaign calls or mail – at least for the next several months.

Now the hard work of governing takes place and we as people of faith need to continue to pray for and raise our voices with the newly elected and those who continue to

serve us to help alleviate hunger, poverty, homelessness, and create a cleaner, more sustainable environment.

In our synod we have a new mayor in Seattle and a new county executive. In Everett the incumbent mayor continues as well as the Snohomish county council members that were up for election.

The two statewide election issues – Initiative 1033 was defeated (this was the effort to limit local and state government's ability to raise revenue) and Referendum 71 was approved (the state law that extends marital rights to same sex partners and heterosexual partners over 62 that are registered with the state).

The state legislature convenes on Jan. 11 – please keep them and our governor in your prayers as they will face a \$2 billion plus revenue shortfall.

The governor released her balanced budget on Dec. 8. (It's posted on the LPPO website.) Out of a \$31 billion total state budget \$21.5 billion is "untouchable" or mandated by the federal government or by our state constitution (such as Medicaid and K-12 education).

This meant she and the legislature had to cut from the other \$9.5 billion, which are health and human service programs and the Department of Corrections.

The governor and the legislature have no easy task ahead of them.

About 90 people showed up for a meeting with Bishop Boerger at Prince of Peace in Everett on November 14 to discuss the topic of the sexuality decisions made at the ELCA Churchwide Assembly August 2009.

While there were some emotional moments during the meeting, everyone conducted themselves in a polite and civil manner. Many questions were asked of the bishop on how one could stay in the ELCA when one thinks these decisions on homosexuality were against Biblical principles. Bishop Boerger gave many suggestions how one might do that. He also advised against putting this matter to a vote for fear of splitting congregations. He assured everyone that congregations would not be forced in any way to call a pastor they did not want. He further said that pastors who oppose these controversial decisions would not be discriminated against in the call process -- for being against the ELCA decision.

Bishop Boerger reported that the conference of bishops is still working on a satifactory process for advancing pastors in gay relationships to serve in our congregations. When asked whether or not pastors in gay relationships would be expected to declare to congregations their preference, he said they would be.

Early in the meeting Bishop Boerger responded to a question saying that he did not believe these decisions put the ELCA is direct violation of the Bible. He explained that just as Acts 15 overturned the necessity of circumcision in Genesis 17, so the ELCA has justifiably overturned the sinfulness of homosexual behavior as stated in Leviticus 18 and Romans 1 -- at least as it pertains to gays in committed, loving relationships. Bishop Boerger also said he would be happy to visit our congregations to discuss further any of these matters. At the end of the session it was still very clear how wide and deep the divide is between the opposing views on this matter in the church.

### Here 'n There

■ In the summer of 2010 the fourth delegation of youth from the NE Seattle partner churches (Faith, Maple Leaf, Prince of Peace and University) will head to Ailanga Lutheran

Junior Seminary in Usa River, Tanzania. The youth are currently busy raising funds to support this mission outreach project. Past delegations have raised funds that helped the school to build dormitory space, a science lab and a computer lab. Some school scholarship money has also been raised.

- University Lutheran in Seattle was part of the U Distric Conversation on Homelessness held in November. The conversation included a mixture of people from the faith community, civic community and business community. Discussions centered around how services with homeless people can be better coordinated throughout the University District as well as how to advocate for these individuals at a city and county level.
- The Sky Valley Food Bank has recently been providing enough food each month for more than 50,000 meals. Morning Star in Monroe supports the food bank.
- Bethany Lutheran on Bainbridge Island held a humor fundraiser to raise funds for LATCH. Besides having a lot of fun more than \$1300 was raised. The congregation also recently held a Fair Trade Fair where more than \$3000 was raised to address poverty world-wide by providing sustainable wages for artisans' families.



## Here 'n There

- In January members of **Faith in Redmond** will be providing dinners on two separate nights for homeless men who are able to stay at Redmond Methodist Church. The church provides a warm place for them to sleep and the kitchen facilities for them to make breakfast and lunch with donated provisions. Faith is just one of many churches who provide dinners to the men.
- The Sunday School classes at **Our Savior's in Stanwood** are using their offerings from December to be used for *God's Global Barnyard*. So far they have collected enough money for one pig and a flock of chickens.
- Central in Seattle has received a \$10,000 grant from Seattle Public Utilities to remodel their parish hall. Central received the grant because the congregation is part of a project to rescue food from the waste stream in Seattle. It is estimated that one third of all waste in Seattle is from food. Since Community Lunch (a program at Central) receives food from restaurants and supermarkets and they estimate that they recover 96 tons of food each year.
- **Trinity in Freeland** supports the homeless in Seattle through meals, clothing and other items. In late October they were able to feed 100 people a lunch and give some much needed, and appreciated, clothes and quilts.
- Duck the malls and join **Church of the Beloved** for an evening of holiday celebration hosted by a few talented artists and crafters. Light refreshments will be served while you listen to live music. The bazaar will take place on Friday, Dec. 18, from 3:30 to 8:30 pm at the Rosewood Manor, Lynnwood. # From the Board of Pensions Update

#### What's two percent?

Your congregation or organization's ELCA health contribution will increase two percent in 2010. Two percent also happens to be what your congregation or organization could save

on these contributions in 2010 if your synod collectively reaches 65% Mayo Clinic Health Assessment participation Jan. 1 - April 30. Earning the two percent contribution discount in 2010 will effectively offset your rate increase for 2010. Encourage your employees with ELCA-primary health benefits to take the health assessment when it opens on the EmbodyHealth web portal Jan. 1. It's an act of stewardship for this church. (And your employees earn a \$150 personal wellness account credit in the process.)

Flexible Spending Plan (FSA)

Employees with ELCA-primary health coverage who want a 2010 flexible spending account should return the enrollment form (signed by you). Final deadline, faxed or post-marked, is Dec. 31.
